<sup>\*</sup> Excluded from adjusted net earnings are the effects of other charges, most significantly the write-down of goodwill and long-lived assets, gains or losses on the repurchase of shares or debt and the related income tax effect of these adjustments, and any significant deferred tax write-offs or recovery. The company also excludes some recurring charges such as restructuring costs, total stock-based compensation, including option expense and restricted stock expense, the amortization of intangible assets (excluding amortization of computer software), and the related income tax effect of these adjustments.

<sup>\*\*</sup> Excluded from EBIAT are the effects of other charges, most significantly the write-down of goodwill and long-lived assets, gains or losses on the repurchase of shares or debt and the related income tax effect of these adjustments, and any significant deferred tax write-offs or recovery. The company also excludes some recurring charges such as restructuring costs, total stock-based compensation, including option expense and restricted stock expense, the amortization of intangible assets (excluding amortization of computer software), interest expense or income, and the related income tax effect of these adjustments.
